O R D E R

After constitution of Integrated West Bengal Agricultural Service (Administration) vide order No.4522-Estab.(Dte.)/12A-18/2005 dated 21.09.2007 and consequent upon framing of the Revised Recruitment Rules issued vide notification No. 2224- Estab.(Dte.)/12A-18/2005 (Part-I) dated 29.06.2009, a question was raised whether the officers, upon being transferred on higher responsibilities as per Revised Recruitment Rules to the posts of Deputy Director of Agriculture, Joint Director of Agriculture, Additional Director of Agriculture and Project Coordinator & Ex-officio Additional Director of Agriculture, as applicable, are entitled to get the benefit of pay fixation under Rule 11 of West Bengal Services (Revision of Pay & Allowances) Rules, 2009.

After careful consideration, the Governor is pleased to decide that such officers are entitled to get the benefit of pay fixation under Rule 11 of WBS (ROPA) Rules, 2009 from the date of joining upon transfer on higher responsibilities to the posts of Deputy Director of Agriculture, Joint Director of Agriculture, Additional Director of Agriculture and Project Coordinator & Ex-officio Additional Director of Agriculture, as the case may be, as per proviso laid down in the revised Recruitment Rules notified vide No.2224-Estab.(Dte.)/12A-18/2005 (Part-I) dated 29.06.2009, since their transfer to the posts of Deputy Director of Agriculture, Joint Director of Agriculture, Additional Director of Agriculture and Project Coordinator & Ex-officio Additional Director of Agriculture in the Integrated West Bengal Agricultural Service (Administration) involve assumption of higher responsibilities.

This order shall come into force on and from 29.06.2009.
