NOTIFICATION

In pursuance of Finance Department's Memo No. 6075-F dated 21.06.1990 regarding Career Advancement Scheme, the Governor has been pleased to order that Shri Kartick Chandra Hansda, an Officer borne in the W.B.A.S (Admn.) Cadre who has completed 10 (ten) years of continuous and satisfactory services in the Scale of Pay of Rs. 2,200-80-3,000-100-4,000/- and its corresponding unrevised Scale taken together without any promotion in his Career in W.B.A.S (Admn.) be moved to the next higher Scale of Pay of Rs. 3,000-100-3,500-125-4,750/- under W.B.S. (ROPA) Rules, 1990 with effect from 20.10.1997.

2. Shri Hansda will be entitled to get benefit in the Scale of Pay of Rs. 3,000-100-3,500-125-4,750/- notionally with effect from 20.10.1997. Shri Hansda will not be entitled for any benefit of arrear pay in the unrevised Scale of Pay of Rs. 3,000-100-3,500-125-4,750/- under W.B.S. (ROPA) Rules, 1990 and its corresponding revised Scale of Pay under W.B.S. (ROPA) Rules, 1998 & W.B.S. (ROPA) Rules, 2009 and allowances till 13.06.2012.

3. Shri Hansda will continue to draw other allowances as admissible in terms of existing Government Orders in addition to his Pay in the unrevised Scale of Pay of Rs. 3,000-100-3,500-125-4,750/- under W.B.S (ROPA) Rules, 1990 and its corresponding revised Scale of Pay under W.B.S. (ROPA) Rules, 1998 & W.B.S. (ROPA) Rules, 2009 which is being allowed to him with effect from 14.06.2012.

4. The charge will proceed against the appropriate Head of Account in the State Budget.
